## TRANSACTION UPDATE

**Toronto, Ontario –April 3, 2014 – Satori Resources Inc. (TSXV:BUD) (“Satori” or the “Company”)** announces that on March 11, 2014, the Company disclosed that it will be evaluating investment opportunities in various sectors, which the Company confirms, includes those in the agricultural/medical marijuana sector. Following the changes in legislation in the medical marijuana industry, both in Canada and the United States, there has been substantial speculative interest in this new sector, as well as in Satori Resources, as reflected by the trading volume and stock price.
